the Union has been created by the Autonomous Region Friuli Venezia Giulia as a result of Regional Law n. 26/2014. 11 local municipalities of the coastal area have been gyregated in the Union and some functions and competences previously in charge to ocal municipalities transferred. Union is responsible for the local development of the oastal area of Bassa Friulana with a strategic role in the coordination of services elated to territorial, economic and social development. UTI is in charge for elaborating the Local Development Strategy and Plan and for ensuring implementation of local evelopment programmes, as well as on public services of general interest and management of municipal budget and on EU planning. In addition, to UTI has been transferred also competences on the environmental sector, and for promotion of plan protection measures.

#### Organisational structure and resources

The Union aggregates 11 municipalities of FVG Region: Lignano Sabbiadoro, Carlino, Latisana, Marano Lagunare, S.Giorgio DN, Ronchis, Muzzana DT, Palazzolo dello Stella, Pocenia, Porpetto and Precenicco, with a population of 47.000 inhabitants. The Union benefits from municipalities employers and some of them are in the process of being formerly transferred to the Union: they have experience on management of public funds, strategic planning and programming and technical expertise in the different fields related to UTI competences. The Union is leaded by a President, that is the Mayor of the most populated municipality and is governed also by an Assembly, composed by the mayors of all municipalities included in the Union. Having a surface of 17.000 Ha (45% of total HA) of wetlands areas, Natura 2000 protected and special zones and regional reserve, the Union structure has competences and knowhow on biodiversity protection and preservation and on promotion of its sustainable management.

#### **Expertise in EU/International projects**

Being competences on EU planning and management transferred to Union in 2016, the Union rely on knowhow and experience of Lignano and Marano (among others IT SLO 07-13 Tricorala Project for protection of reefs,IPA ADRIATIC 07-13 ECOSEA Project for pilot actions for increasing fishing resources and SHAPE Project for management of the natural resources of coastal areas and transitional water monitoring system). The Union is supported by Informest, Development Agency established in the '90s by the A. Region FVG and empowered in 2014 with a MoU for assisting and supporting the local authorities capacity of absorbing EU funds for improving local communities quality of living, services, facilities and environment. Informest has a 20 year experience in national, transnational and crossborder cooperation, building up partnership and networks all over Europe and is skilled also on capacity building and strategic territorial and social local development and creation of awareness campaigns.

#### Benefits on participation

UTI Riviera territory includes the Marano lagoon, one of the most important lagoons and wetlands of North Italy. The whole area is protected by Nature 2000 network due to the intensive presence of rare habitats and species. In the project, UTI will share its experience in managing this important wetland and compare its techniques with other partners. The result of this joint sharing will produce an useful tool for the whole cooperation area (the wetlands contracts) that will guarantee the correct management of this wetland in the future. The Marano lagoon will become a pilot area and the results could be applied in all coastal wetlands (Venice lagoon, Po mouth and many smaller areas). In addition, the participatory approach with wetland actors and stakeholders to be implemented within the local labs is perfectly in line with UTI Development Plan.

Competence	Founded in 2004 in accordance with Nature Protection Act, the Institution manages 34 protected areas and 90 Natura2000 sites within Dubrovnik-Neretva County. Its competences are consistent with the proposal since it coincides with its primary activities: protection, maintenance and promotion of protected natural areas, aimed at preserving nature, ensuring the undisturbed progress of natural processes and sustainable use of natural resources. It supervises the implementation of nature protection requirements and measures in the managed area and participates in monitoring the state of nature conservation. Neretva River Delta is one of the main focus of the Institution, due to exceptional natural values, presence of important reserves and other protected areas, Natura 2000 SPA, SCI and Ramsar site, but also of various impacts. The Institution employs professional staff to carry out conservation activities, with an emphasis on biological and biotech orientation, and administrative experts.
Organisational structure and resources	The Institution consists of 8 workers and a Director. The structure is formed of Director, Expert, Fire prevention and Ranger departments. Director#-#s department employs 2 professionals for promotion and project activities. Expert department consists of 2 biological and biotechnological experts. The Fire protection department consists of a fire protection and forestry expert. Ranger department consists of 2 professionally trained workers. The seat of the Institution is in Dubrovnik, in premises of Dubrovnik General Hospital, which are awarded for use. The Institution owns a car, offices equipped with technical equipment and field equipment needed for activities that are implemented on the basis of legal regulation. One of them is Annual Program for the protection, maintenance, preservation, promotion and use of protected areas of Dubrovnik-Neretva County.

#### Territorial challenges tackled

Wetlands are complex ecosystems of paramount importance: they are considered among the most productive environments of the World, they contain major biodiversity hot spots, providing the resources upon which countless species of plants and animals depend and they perform important environmental and economic functions. Wetlands reduce flooding events, improve water quality and represent a valuable cultural and natural heritage. Italy and Croatia count on a rich variety of coastal wetlands that, together with the plants and animals inhabiting and crossing them, constitute an extremely precious natural heritage. Nevertheless, coastal wetlands are extremely rare and fragile ecosystems. Although rivers and wetlands are object of diverse international initiatives (Ramsar Convention, Natura2000, EU projects enhancing monitoring and management systems), ecosystems, indigenous and endemic species are threatened by degradation and extinction. Common pressures include: 1) productive systems causing water consumption and pollution of water and soil; 2) strong urbanization and population growth (often associated with undeveloped/nonexistent public sewerage systems) causing habitat loss and fragmentation; 3) climate change; 4) unsustainable tourism, particularly during the summer season; 5) invasive alien species introduction and eutrophication; 6) overlapping of different levels of spatial planning and duties by authorities in charge for their preservation and management and scarce coordination and capabilities of administrative authorities to handle complex territorial dynamics; 7) rarely taken into account of rivers and wetlands in territorial development strategies. It is estimated that 2/3 of Europe wetlands have disappeared since the beginning of the 20th Century, mainly lost through development processes which did not take their functions and values adequately into account. Because of these threats, the management of wetlands and the protection of their biodiversity requires to overcome the sectorial and localized approach implemented until now and needs to tackle the problem from an eco-systemic point of view and an integrated cross border approach. #### Project approach

Build on knowledge	CREW draws on the tendency that tackles environmental governance of water resources with River Contract and water management projects. The World Water Forum, which took place in Aja in 2000, defines the River Contract as "an agreement the allows to adopt a set of regulations in which criteria of public utility, economic return, social value and environmental sustainability equally take part in the search for effective solutions for the river basin recovery."
